Protective gloves

Butyl rubber (0,7 mm) EN 374

As there are many different conditions in every day work these indications can only serve as an aid to orientation for the selection of suitable gloves for the handling of chemical products. By no means they can replace qualifying examinations by the end-user.

The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer. The exact break trough time has to be found out by the manufacturer of the protective gloves and has to be observed.

The determined penetration times according to EN 374 part III are not performed under practical conditions. Therefore a maximum wearing time, which corresponds to 50% of the penetration time, is recommended.
